

# Microbiology Clinical Details Guide

**August 2019**

Our objective is to receive brief but pertinent clinical details on all diagnostic microbiology samples, which we believe will optimise the quality of the results that we release. We also believe that such an approach will have positive effects on antimicrobial stewardship.

The rationale for clinical details can be split into three areas of the testing process; pre-analytical, analytical and post-analytical. There will however be overlap between the three areas:

**Pre-analytical:** Clinical details allow us to decide if the test is appropriate for a given clinical situation, and whether extra or alternative testing may be indicated.

**Analytical:** This area is particularly important for samples which are processed for bacterial culture. Clinical details can (and often does) affect any of the following steps in the bacteriology culture process:

- Whether additional tests in addition to culture are indicated.
- Whether a Gram stain/microscopy is performed.
- What incubation conditions are used (aerobic/CO2/anaerobic) for the culture plates.
- Which culture media are set up on the sample.
- Ascertaining the relative significance of different culture isolates and deciding further workup.
- Whether susceptibility testing should be performed, and what antimicrobials to test against.
- Which culture isolates should be reported to the requestor.
- Which antimicrobial susceptibilities are released to the requestor.
- Whether an interpretative comment is added to the final report.

**Post-analytical:** This allows us to decide whether the culture findings are consistent with the clinical details, which antibiotics should be reported, if any, which interpretative or management comments should be added.

This Guide contains clinical details that are acceptable and unacceptable for the specimen types listed below. This is not an exhaustive list and will be developed further over time.

## Urine Samples

Clinical details are particularly important amongst patient cohorts who have a high prevalence of asymptomatic bacteriuria such as older people, rest home residents, patients with long term urinary catheters.

A brief summary of the patient's specific symptoms, accompanied by any other useful information such as pregnancy, immunocompromising conditions, current antibiotics, allergies, etc. all contribute to how the sample is processed in the laboratory, what susceptibilities are performed and how the result is reported back to the requestor.

"?UTI"/"UTI" or similar **will** be accepted for testing. However, this is essentially a diagnosis as opposed to relevant clinical details and we strongly discourage this practice. The patient's specific symptoms should be stated as detailed above. This helps the laboratory decide between an uncomplicated and complicated UTI and whether the upper renal tract may be involved. These decisions affect which antibiotics are tested, whether an antibiotic is interpreted as susceptible or resistant and which susceptibility results are reported back to the requestor.

## Superficial Wound/Skin swabs

The diagnosis of wound infection is essentially a clinical diagnosis, with laboratory testing used to provide further information to guide management, particularly when the use of systemic antibiotics is deemed appropriate. The table below outlines what we would regard as acceptable and unacceptable clinical details:

Acceptable Clinical details	Unacceptable Clinical details
<p><b>Symptoms</b></p> <ul style="list-style-type: none"> <li>• New or increased pain</li> <li>• Swelling</li> <li>• Erythema</li> <li>• Purulent exudate</li> <li>• Localised warmth</li> <li>• Systemic signs (fever, tachycardia, etc.)</li> </ul> <p><b>Diagnoses/Clinical Scenarios</b></p> <ul style="list-style-type: none"> <li>• Post-surgical wounds</li> <li>• Bite wounds</li> <li>• Superficial burns</li> <li>• Penetrating wounds</li> <li>• Diabetic foot infections</li> <li>• Skin grafts</li> <li>• Extensive eczema</li> <li>• Extensive impetigo</li> <li>• Cellulitis (only if associated skin break/wound)</li> <li>• Infected wounds that have not responded to standard management</li> </ul>	<ul style="list-style-type: none"> <li>• <b>No clinical details</b> (i.e. blank or just test request)</li> <li>• <b>Chronic wounds/ulcers</b> These chronic lesions are inevitably colonised with bacteria, so the positive predictive value of the culture result is low. These samples will <b>only</b> be accepted if accompanied by specific clinical details suggesting infection.</li> <li>• <b>Peri-anal and groin wounds</b> These are also low yield due to high contamination rate with enteric flora. These samples will <b>only</b> be accepted if accompanied by specific clinical details suggestive of infection.</li> <li>• <b>Unlabelled Site</b> Normal colonising flora differs at different sites of the body. If the site is unknown, the importance of isolated bacteria cannot be properly assessed.</li> </ul>

## Sputum Samples

Bacterial culture of sputum samples suffers from both poor sensitivity and specificity, leading to sub-optimal antimicrobial stewardship.

Sputum samples on immunocompetent patients from the community who simply present with cough with no other complicating factors will **not** be accepted. International guidelines do not support the use of sputum cultures in non-hospitalised patients with acute bronchitis or mild community acquired pneumonia.

## Faeces Samples

### Infective Gastroenteritis testing

Testing is only indicated if severity or Public Health risk factors are present, (refer to Faeces – Enteric Pathogen Laboratory Testing Guide). For bacterial and routine parasite (giardia, cryptosporidium) investigations only **ONE** faeces specimen is required.

<ul style="list-style-type: none"> <li>• <b>Food handler</b></li> <li>• <b>Childcare attendance</b></li> <li>• <b>Rural</b> (including camping trips, farm visits, untreated water supply)</li> <li>• <b>Raw seafood</b></li> <li>• <b>Overseas travel</b> (specify countries visited)</li> <li>• <b>Recent antibiotics or chemotherapy</b></li> <li>• <b>Bloody diarrhoea</b></li> <li>• <b>Immunocompromised</b> (includes pregnancy)</li> <li>• <b>Persistent diarrhoea</b> (&gt;1 week)</li> <li>• <b>Public Health request in outbreak situation</b></li> </ul>	<ul style="list-style-type: none"> <li>• <b>No clinical details</b></li> <li>• <b>No risk factors indicated</b></li> <li>• <b>Diarrhoea</b></li> <li>• <b>Abdominal discomfort</b></li> <li>• <b>Diarrhoea for &lt;1 week with no other risk factor</b></li> </ul>

### *Helicobacter pylori* stool antigen testing

The clinical presentation of *H. pylori* infection is very different from that of infective gastroenteritis and testing for both will not be done in conjunction with the other. In addition, our assay for *H. pylori* antigen detection is neither recommended nor validated for unformed stool samples.

Acceptable Clinical details	Unacceptable Clinical details
<p><b><u>Dyspeptic Symptoms</u></b></p> <ul style="list-style-type: none"> <li>• Heartburn</li> <li>• Abdominal discomfort</li> <li>• Nausea/vomiting</li> <li>• Anorexia</li> <li>• Excessive belching/burping</li> </ul> <p><b><u>Diagnoses/Clinical Scenarios</u></b></p> <ul style="list-style-type: none"> <li>• “Gastritis”</li> <li>• Unintentional weight loss</li> <li>• History of peptic ulcers</li> <li>• Suspected, confirmed or family history of gastric carcinoma</li> <li>• Chronic urticaria</li> <li>• Family history of <i>H. pylori</i> infection</li> <li>• Endoscopic evidence of ulceration</li> <li>• Monitoring of treatment of <i>H. pylori</i> infection (&gt;8 weeks post treatment)</li> </ul>	<ul style="list-style-type: none"> <li>• <b>No clinical details</b></li> <li>• <b>Signs/Symptoms suggestive of infective gastroenteritis</b></li> <li>• <b>Requested in conjunction with infective gastroenteritis</b> (enteric bacterial PCR panel)</li> </ul>

## Vaginal Swabs

Testing of genital swabs is separated into two distinct categories, molecular testing for STI's and microbiology microscopy/culture (e.g. BV, thrush).

- Molecular STI swabs (black cap tube for chlamydia/gonorrhoea/trichomonas), will be processed but relevant clinical details are recommended as they assist in result interpretation and appropriate interpretive comments.
- Microbiology microscopy/culture swabs (white cap swab), will be rejected if relevant clinical details are not provided. The table below outlines acceptable and unacceptable clinical details.

## Ear Swabs

There is a paucity of evidence to support the clinical usefulness of ear swabbing in otitis externa, and guidelines based on expert opinion do not recommend ear swabbing in uncomplicated otitis externa infection.

Acceptable Clinical details	Unacceptable Clinical details
<ul style="list-style-type: none"> <li>• <b>Otitis media</b></li> <li>• <b>Perforation / Grommets with discharge</b></li> <li>• <b>Recalcitrant otitis externa</b> (which has failed initial treatment with ear drops)</li> <li>• <b>Recurrent or chronic (&gt;2 weeks) otitis externa</b></li> <li>• <b>Topical treatment can't be delivered effectively</b></li> <li>• <b>Evidence infection extends beyond the external auditory canal</b> (e.g. osteomyelitis, cellulitis, nerve palsy)</li> <li>• <b>Condition is complex/severe enough to warrant systemic antibiotic treatment</b></li> <li>• <b>Systemic symptoms</b> (i.e. fever)</li> <li>• <b>Immunosuppression</b></li> <li>• <b>ENT Specialist request</b></li> </ul>	<ul style="list-style-type: none"> <li>• <b>No clinical details</b></li> <li>• <b>Otitis externa</b></li> <li>• <b>Earache</b></li> <li>• <b>Ear discharge</b></li> </ul>
